Dal 1989 al 1998 è stata Ricercatore per il SSD C07X – Chimica Farmaceutica. Dal 1998 ad oggi è Professore associato di Chimica Farmaceutica per il SSD CHIM08 – Chimica Farmaceutica. Ricopre per incarico il corso di Laboratorio Chimico Farmaceutico (8 CFU) del C.d.L. in CTF e di Analisi dei Medicinali (2 CFU) del CdL in Farmacia presso il CdS di Farmacia. Ha afferito sino dal 1982 prima all'Istituto di Chimica Farmaceutica e successivamente al Dipartimento di Scienze Farmaceutiche. Ad oggi afferisce al Dipartimento di Scienze Chimiche e Farmaceutiche.

L'attività di ricerca si è articolata nei due settori della Analitica farmaceutica, con la determinazione di principi attivi e loro metaboliti in forme farmaceutiche e liquidi biologici, e della sintesi in chimica farmaceutica con lo sviluppo di nuovi composti antiipertensivi. Attualmente si occupa della progettazione e sintesi di nuovi farmaci antifungini e antimicobatterici e del disegno e sintesi di nuovi ligandi del recettore sigma.
