- the title of the thesis indicated on the online application for the degree award must be the same as that given on the thesis form signed by the supervisor and that on the submitted electronic version of the thesis;
- as the electronic version constitutes the official record, the submitted thesis cannot be in any way replaced or modified after submission;
- after submission to the ThesiS electronic system, the thesis will be indexed and consultable (where applicable);
- in completing this form, s/he also accepts the information given online regarding the consultation (\*) of the thesis submitted in electronic format to the University's ThesiS archive. This archive is accessible through the University of Trieste intranet.

**(\*) Authorisation/Non-Authorisation to CONSULT a thesis**

1. The full-text version of an archived thesis can be consulted only if the author has authorised such consultation.
2. The ThesiS system contains and publishes the metadata (title, author, etc.) of all degree theses, even those for which full-text access has not been granted.
3. Full-text access is limited to University users (students, teaching staff, personnel) via the University intranet or from home via the EZ-Proxy (authentication with University username and password).

As author of the degree thesis, the graduate maintains the intellectual, moral and economic rights as under current law (Law 633/1941 and subsequent modifications and additions).

The administration must undertake appropriate measures, including sample checks, to verify the veracity of declarations in lieu.
