International Training Seminars on the EOPP and ESCP Regulations

The European Order for payment procedure (EOPP) is an EU-wide instrument for easy attainment of enforceable decisions on payment obligations in cross-border transactions. The European small claims procedure (ESCP) was established by the EU to simplify and expedite, as well as lowering the costs for resolutions of small claim cases in cross-border transactions. In these two training seminars, the European payment procedure and the European small claims procedure will be presented and a review of their use in practice will be made.

The seminars are organised as part of the *Train 2 En4ce*, a combined research and training project aimed at facilitating free movement within the EU for legal decisions, primarily concerning payments. These seminars are the final in a series of three.

Through an unusual combination of legal research and professional training for lawyers, *Train 2 En4ce* is intended to increase knowledge regarding the legal possibilities within the EU for enforcement and to increase mutual trust between bodies operating within the various EU national legal systems. The project is conducted by legal scholars in co-operation with lawyers working in different EU-countries.

Together with several other European universities, the University of Trieste is a partner in the project, which has been ongoing since the Autumn 2019 and will end this year. Professor Sara Tonolo is responsible for the Italian part of the project together with Professors Domenico De Stefano, Francesca Fiorentini, Alessandra Frassinetti, Marta Infantino and Giuseppe Pascale. Researchers and teachers from Uppsala University, Sweden, are the main organisers for these two seminars.
